


This modification increases the target cost and fee to CLIN C – Balance of ICP for the directed change to prepare air permits that will allow inorganic sludges within the Sludge Repackaging Project under Section C.8.2.5 ARP V Permit (ID-0013B.08). This modification also reduces the target cost and fee to CLIN C – Balance of ICP for the directed deductive change associated with the recent agreement with EPA and IDEQ on a path forward for the Tank Farm Cap under Section C.8.4.4.2 Tank Farm Cap Construction (ID-0030B.05).

1. B.14 EXTENSION - TOTAL CONTRACT TARGET COST, FEE, AND COMPLETION DATE paragraph (c) is modified as follows:

- (c) CLIN C – Balance of ICP: The total contract target cost and target fee are based on a period of performance from October 1, 2012, through September 30, 2015.

The target cost is decreased by \$36,684 from \$481,091,869 to \$481,055,185.

The target fee is decreased by \$2,700 from \$35,408,361 to \$35,405,661.

2. B.15 EXTENSION INCENTIVE FEE paragraph (c) is modified as follows:

- (c) CLIN C – For the balance of the ICP work scope, the following cost incentive structure is established for a period of performance from October 1, 2012 through September 30, 2015.

Cost Incentive

Target Cost: \$481,055,185

Target Fee: \$35,405,661 (7.36% of target cost)

Maximum Fee: \$72,158,278 (Maximum Fee must not exceed 15% of target cost)

Minimum Fee: \$0.00

Fee Calculation: The fee payable under this contract shall be the target fee increased by thirty (30) cents for every dollar that the total allowable cost is less than the target cost or decreased by thirty (30) cents for every dollar that the total allowable cost exceeds the target cost as specified in FAR 52.216-10 and subject to the maximum fee limitation above for work performed under Section C.8. If there is a fee reduction as a result of failure to meet identified milestones in CLIN A (Refer to B.15(a) above), it will be accomplished by fee reduction in this CLIN C.

3. C.8.2.5 ARP V PERMIT (ID-0013B.08) is revised to incorporate the second paragraph related to inorganic permits for the sludge repackaging project. The revised scope is as follows:

The Contractor shall maintain a RCRA permit and Toxic Substances Control Act (TSCA) risk based disposal approval for Accelerated Retrieval Project (ARP) V to allow use of ARP V to treat waste stored at AMWTP. The Contractor shall enter into an agreement with the AMWTP Contractor to receive stored waste. Delivery of the waste to the Contractor at an acceptable rate is a government furnished service and will be performed by the AMWTP Contractor. The Contractor shall treat 6,000 drums of AMWTP waste by September 30, 2014.

The Contractor shall prepare the necessary air permits that will allow the potential future processing of Inorganic Sludges within the Sludge Repackaging Project. This scope must be completed by December 31, 2013, but does not include agency approval.

This directed change results in a CLIN C target cost increase of \$49,756 and a target fee increase of \$3,662.

4. **C.8.4.4.2 TANK FARM CAP CONSTRUCTION (ID-0030B.05)** has been revised in its entirety as a result of negotiations with EPA and IDEQ. The revision is as follows:

In March 2013, the CERCLA regulators agreed to revise milestones for completion of OU 3-14, Tank Farm Soil and INTEC Groundwater. All milestones are now beyond the contract period. The milestone to submit a revised draft of the RD/RA Work Plan (DOE/ID-11333) to the Agencies by June 27, 2013, was eliminated. However, the Contractor shall complete a minor revision to the RD/RA Work Plan (DOE/ID-11333) for Agency acceptance by June 27, 2013, to make it consistent with the approved revised milestones and approaches agreed to by the Agencies.

The Contractor shall complete a draft Interim Remedial Action Report for OU 3-14, Phase I to support submittal to the Agencies by November 27, 2012.

This deductive change results in a CLIN C target cost decrease of \$86,440 and a target fee decrease of \$6,362.

5. **C.8.4.4.3 TANK FARM CAP CONSTRUCTION (ID-0030B.C5)** has been revised in its entirety as a result negotiations with EPA and IDEQ. The revision is as follows:

Tank Farm paving or cap construction, if accelerated to be completed during the contract period, will be separately ordered pursuant to Section I.81, Changes Clause.

6. **CONTRACTOR'S STATEMENT OF RELEASE:** In consideration of the modification agreed to herein as a complete equitable adjustment for the directed change to prepare air permits that will allow inorganic sludges within the Sludge Repackaging Project under Section C.8.2.5 ARP V Permit (ID-0013B.08) and for the directed deductive change associated with the recent agreement with EPA and IDEQ on a path forward for the Tank Farm Cap under Section C.8.4.4.2 Tank Farm Cap Construction (ID-0030B.05). Also in accordance with contract Section I.81 52.243-2 Changes—Cost

Reimbursement Alt I, the Contractor hereby releases the Government from any and all liability under this contract for further equitable adjustments attributable to such facts or circumstances giving rise to the proposal for adjustment. The total target price of the equitable adjustment is a decrease of \$39,384.
