In accordance with Contract Clause I.81, *52-243-2 Changes – Cost Reimbursement (AUG 1987) and Alt I (APR 1984)* and Contract Clause I.22, *52.216-10 Incentive Fee (MAR 1997)*, this modification incorporates a target cost (\$80,282,437) and target fee (\$5,908,788) downward adjustment under Section B.3, *Total Contract Target Cost, Fee and Completion Date* for General and Administrative (G&A) proposed costs allocated from target to non-target work scope under *Section B.5, Items Not Included in Target Cost* (referred to as B.5). This modification also incorporates a similar target cost (\$4,437,776) and target fee (\$326,620) downward adjustment for fringe costs allocated from the original target to non-target work scope under *Section B.5, Items Not Included in Target Cost*.

Finally, this modification increases the fixed fee under B.5 for the G&A costs that were allocated from Target to B.5 in accordance with cost accounting standards and CWI's certified disclosure statement.

**1. SECTION B.3 TOTAL CONTRACT TARGET COST, FEE, AND COMPLETION DATE**, paragraph (a) is modified as follows:

(a) The target cost of this contract is comprised of the following two (2) items:

- 1) SBW project at \$316,000,000, and
- 2) Balance of the Idaho Clean-up Project (ICP) work is decreased \$84,720,213 from \$2,343,938,320 to \$2,259,218,107.

The target fee for this contract is decreased \$6,235,408 from \$195,586,684 to \$189,351,276 (7.36% of target cost).

**2. SECTION B.4 INCENTIVE FEE**, (a), first paragraph, is modified as follows:

(a) Cost Incentive

The following cost incentive structure is established in association with a completion date of September 30, 2012:

Target Fee: \$189,351,276 (7.36% of target cost)

Maximum Fee: \$310,000,000 (Maximum Fee must not exceed 15% of target cost)

Minimum Fee: \$0.00

Fee Calculation: The fee payable under this contract shall be the target fee increased by thirty (30) cents for every dollar that the total allowable cost is less than the target cost or decreased by thirty (30) cents for every dollar that the total allowable cost exceeds the target cost as specified in FAR 52.216-10 and subject to the maximum fee limitation above.

The remainder of B.4 remains unchanged with this contract modification.

3. **SECTION B.5 ITEMS NOT INCLUDED IN TARGET COST** is modified as follows:

This modification adjusts the fixed fee upward by \$4,790,066 as requested by CWI on March 27, 2013 (CCN 314806).
