The purpose of this undefinitized contract modification is to modify CLIN 00003 by incorporating Section C.7.4, CPP-603 Large Cask Adaptation Project Turnover. This modification is being made under the authority of the contract clause Section I.99, *Changes – Cost Reimbursement (AUG 1987) - Alternate II and III (APR 1984)*.

Effective June 1, 2016, the Contractor is authorized a not to exceed (NTE) of \$825,000 in direct costs for the work under this modification, consistent with the other contract terms and conditions of the contract and until this change is definitized. The NTE does not include fee or the overhead allocation from CLIN 00001. Fluor shall invoice fully burdened costs. Once negotiations are finalized, Section B and CLIN 00003 will be revised accordingly as part of the definitized modification.

The following changes are hereby made to the contract:

1. SECTION Section C.7.4, CPP-603 Large Cask Adaptation Project Turnover is incorporated with the following scope:

The Contractor shall continue uninterrupted services for the detailed final design and analysis for the energy absorbing transfer car insert; support structural detailed analysis and final design; and continuing administration of the subcontract with American Crane & Equipment Corporation for the crane procurement. The Contractor shall also support ad-hoc DOE-ID requests and management briefings.

No other changes to the contract terms and conditions.
